

Voter Information

To vote in any election you must:

- Be a U.S. citizen 18 years of age or older.
- Be registered to vote in Dubuque County

Registration

You may register to vote or change parties on election day at the polls. Proof of identity with a photo I.D., proof of age and residence is required. You may register at the County Auditor’s Office in the Court House anytime during office hours up to ten days before the election. You may also register by post card or at driver’s license stations. Your registration remains valid unless you change your name, change your address, or are convicted of a felony.

Absentee Ballot or Early Voting

If you cannot go to the polls on election day, you may apply to the County Auditor in advance for an absentee ballot. The ballot must be marked and must be mailed to the County Auditor’s office no later than the day before election day. Follow the instructions on the ballot carefully. You may also vote early at appointed locations.
